1. This Invitation for Bids follows the General Procurement Notice for this procurement which appeared in The Guardian, Daily News, Tanzania Daima and Majira of 16th July, 2008
2. The Government of Tanzania has set aside funds for the operation of the Energy and Water Utilities Regulatory Authority (EWURA) during the financial year 2008-09. It is intended that part of the proceeds of the funds will be used to cover eligible payment under the contract for the "Supply of Mobile Laboratory for Petroleum Product".
3. EWURA now invites sealed bids from eligible Suppliers of Mobile Laboratory for Petroleum Products as follows:

4. Bidding will be conducted through International Competitive Bidding procedures specified in the Public Procurement (Goods, Works, Non-Consultant Service and Disposal of Public Assets by Tender) Regulations, 2005– Government Notice No. 97 and is open to all Bidders as defined in the Regulations.

A complete set of Bidding Document(s) in English and additional sets may be purchased by interested Bidders on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of TZS 100,000 (Tanzanian shillings or equivalent convertible currency). Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to Energy and Water Utilities Regulatory Authority.

7. All Bids must be accompanied by a Bid security in an acceptable form in the amount of 2.5% of the bid amount payable to Energy and Water Utilities Regulatory Authority.
