Invitation for Bids

1. This Invitation for submission of Proposals follows the General Procurement Notice No; 1 of 2008/09 for this Project which appeared in The Guardian, Daily News, Tanzania Daima and Majira Issue nos; 4253,5993,1321 and 5306 of 16th July, 2008
2. The Energy and Water Utilities Regulatory (EWURA) has set aside funds for the operation of EWURA during the financial year 2008/09. It is intended that part of the proceeds of the funds will be used to cover eligible payment under the contract for the **Supply of Computer Hardware and Software**.
3. The Energy and Water Utilities Regulatory Authority now invites sealed bids from eligible National **Suppliers of Computer Hardware and Software** under the lots:

4. Bidding will be conducted through the national competitive bidding procedures specified in the Public Procurement (Goods, Works, Non Consultant Service and Disposal of Public Assets by Tender) Regulations, 2005 – Government Notice No. 97 and are open to all Bidders as defined in the Regulations.

Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to Energy and Water Utilities Regulatory Authority.

7. All Bids must be accompanied by a Bid security in an acceptable form in the amount of 2.5% of the bid amount payable to EWURA.
