The Government of the United Republic of Tanzania has received a technical assistance credit from the World Bank and a grant from the Canadian Department of Foreign Affairs, Trade and Development (DFATD) towards the cost for implementation of the Energy Sector Capacity Building Project (ESCBP) and intends to apply part of the proceeds of this credit for eligible payment under the contract for Consultancy services for the provision of Legal Advisory Services to the Natural Gas Division.
2. The services include among other things the following tasks:
 - i. Development of Legal Regulatory Tools
 - ii. Conducting studies and review of documents and
 - iii. Provision of capacity building and training.
3. The Energy and Water Utilities Regulatory Authority (EWURA) now invites eligible consulting firms ("Consultants") to indicate interests in providing the services. Interested consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the services. The shortlisting criteria are: description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc. Consultants may associate to enhance their qualifications.
4. The consultant will be selected in accordance with the procedures set out in the World Bank's Guidelines – Selection and Employment of Consultants under IBRD

Loans and IDA Credits and Grants by the World Bank Borrowers dated January, 2011.

5. Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Consultant Guidelines.
6. Interested consultants may obtain further information at the address below during office hours from 0800 to 1600hrs local time, Mondays to Fridays inclusive except on public holidays.
7. The deadline for submission of Expressions of Interest will be on Monday 10th July, 2017 at 1400hrs local time. Expressions of Interest should be clearly addressed and delivered to the Secretary, EWURA Tender Board, 19th Floor, Room No. B. 1906, LAMP Tower, Kijitonyama and marked “ **REQUEST FOR EXPRESSIONS OF INTEREST FOR CONSULTANCY SERVICES FOR PROVISION OF LEGAL ADVISORY SERVICES TO THE NATURAL GAS DIVISION**”.
