A CALL FOR STAKEHOLDERS' VIEWS ON THE TARIFF REVIEW APPLICATION FROM KISHAPU WATER SUPPLY AND SANITATION AUTHORITY (KISHAPU WSSA) FOR YEAR 2017/18 TO 2019/20

Tariff Application No. TR-W-17-001

On 3rd January 2017 the Energy and Water Utilities Regulatory Authority (EWURA) received a Tariff Application from Kishapu Water Supply and Sanitation Authority (Kishapu WSSA) requesting for tariff adjustment and charges for Year 2017/18 - Year 2019/20 for water supply and sanitation services. According to Kishapu WSSA, the proposed increase will enable them to cover operation costs such as electricity costs, bulk water purchase from KASHWASA, extend service coverage and repair dilapidated infrastructure so that they can maintain and ensure sustainability of the services.

Pursuant to Sub-section 19(2) (b) of the EWURA Act, Cap 414, there shall be a public inquiry meeting on **Thursday**, 20th **July 2017 at SHIRECU Hall in** Kishapu Town from 10:00hrs to collect views of stakeholders including Government Consultative Council (GCC), Consumer Consultative Council (CCC) and the general public on the reasonableness of the proposed tariff application.

Those who wish to submit written comments on the proposed tariff and charges are invited to do so by writing to the Ag. Director General using the above mentioned address before 30th July, 2017.
