On 6th July 2018, EWURA received a Tariff Application from Mbeya Urban Water Supply and Sanitation Authority (MBEYA WSSA) requesting for multi - year tariff adjustment (2018/19 – 2020/21) for water and sewerage services. According to Mbeya WSSA, the proposed increase will enable it to cover the operational and maintenance costs, Personnel expenses, financing capital investment project to area of Mbalizi town and its peripheries and conducting design review on proposed Kiwira source Project, Environmental Impact assessment, Compensation and project construction, replacement of approximately 13,000 meters, and Water protection to the existing 13 water sources.

Pursuant to sub-section 19(2) (b) of the EWURA Act, Cap 414, there shall be a public inquiry meeting on **Thursday, 16th August 2018** at **Mkapa Hall** in Mbeya City from **10:00hrs** to collect views of stakeholders including Government Consultative Council (GCC), Consumer Consultative Council (CCC) and the general public on the reasonableness of the proposed tariff application.

Those who wish to submit written comments on the reasonableness of the proposed tariff and charges are invited to do so by writing to the Director General using the above mentioned address at any time before **30th August 2018**.
