According to Turiani WSSA, the major reasons for requesting tariff review are to cover cost of rehabilitation and replacement of infrastructure, improve water services and extend water networks to unserved areas of Kunke, Msufini and Lusanga A Village.

Pursuant to Section 19(2) (b) of the EWURA Act, Cap 414, there shall be a public inquiry meeting on **Thursday, 6th December 2018 at Community Center in Turiani Town from 10:00hrs**. The main objective of the meeting is to collect views of stakeholders including Government Consultative Council (GCC), Consumer Consultative Council (CCC), Turiani customers and the general public on the reasonableness of the proposed tariff application.

Those who wish to submit written comments on the reasonableness of the proposed tariffs are invited to do so by writing to the Director General using the above mentioned address at any time by **11th December 2018**.
