PUBLIC NOTICE ON CAP PRICES FOR PETROLEUM PRODUCTS EFFECTIVE
WEDNESDAY, THE 2nd AUGUST 2017

The Energy and Water Utilities Regulatory Authority (EWURA) hereby publishes Cap Prices for petroleum products, applicable in Tanzania Mainland. These retail and wholesale prices are applicable effective **Wednesday, the 2nd August 2017**. Hereinafter, kindly, take note of the following:

- (a) Retail and wholesale prices for all petroleum products have changed compared to prices that were published on 1st July 2017. For the month of August 2017, retail prices of Petrol and Diesel have decreased by TZS 36/litre (equivalent to 1.78%) and TZS 44/litre (equivalent to 2.34%) respectively, while retail prices of Kerosene increased by TZS 24/litre (equivalent to 1.34%) respectively. Similarly, compared to the last month publications, wholesale prices of Petrol and Diesel have also decreased by TZS 35.86/litre (equivalent to 1.88%) and TZS 43.87/litre (equivalent to 2.49%) respectively, while wholesale prices of Kerosene increased by TZS 24.26/litre (equivalent to 1.43%). The decrease in Petrol and Diesel local pump prices have been caused largely by decreases in world oil market prices while the increase in Kerosene prices is mainly due to the increase in BPS premiums.
- (b) There is no change in prices of Petrol and Diesel in Tanga region due to the fact that there was no new consignment of petroleum products received through Tanga port in the month of July 2017. As a result, the prices of the two products in Tanga region for the month of August 2017 will remain the same as they were in July 2017. Furthermore, since there was no new consignment of Kerosene received through Tanga port in the month of July 2017, Petrol Station Operators are advised to source Kerosene product from Dar es Salaam. Due to the foregoing, the price of Kerosene for Tanga region will be based on the cost of Kerosene product received through Dar es Salaam port plus bridging cost from Dar es Salaam to Tanga.
- (c) The Authority would like to remind the public that these cap prices can be accessed through mobile phones by dialling ***152*00#** and then following the provided instructions. This service is free of charge and is available in all mobile phone service providers in the country.
- (d) In line with the prevailing sector legislation (**Petroleum Act, 2015, section 166**), prices of petroleum products are governed by rules of demand and supply. EWURA shall continue to encourage competition in the sector by making available petroleum products pricing information including cap prices. This information on prices is intended to enable stakeholders make informed decisions on petroleum prices at any particular time.
- (e) Oil Marketing Companies are free to sell their products at a price that gives them a competitive advantage provided that, such **price does not exceed the price cap for the relevant product as was computed using the approved formula, which was gazetted through the Government Notice No. 216 published in May 2017.**

- (f) All petrol stations are required to publish petroleum product prices on clearly visible boards. The price boards should be clearly visible and should clearly show prices charged, discounts offered as well as any trade incentives or promotions on offer. Consumers are encouraged to purchase from stations that sell products at the most competitive prices and offer better services. **It is an offence not to have prices published on boards located in clearly visible places in front of petrol stations and it will attract punitive measures from EWURA.**
- (g) Retailers must issue receipts printed from an Electronic Fiscal Pump Printer (EFPP) with respect to all sales that they make and consumers are required to **demand and keep those receipts** that clearly show the name of petrol station, date on which such purchase was made as well as, the type of petroleum product (fuel) and price per litre for every purchase they make. This can be used as an exhibit in case of a complaint lodged in the event that the selling price is above the cap price or in case the products sold do not meet the approved specifications and also, provide an assurance that appropriate government taxes on petroleum products purchased are fully accounted for recovery from the Retailers.


