IN THE MATTER OF ROUTINE INSPECTION OF LPG OPERATIONS
AND
IN THE MATTER OF CHECKING ON COMPLIANCE WITH THE LAW FOR FAILURE
TO COMPLY WITH EWURA ORDERS AND DIRECTIVES

PRELIMINARIES

On 26th November 2024, EWURA sent two Petroleum Inspectors to conduct an inspection at Enocy Shop & General Supply located at Nendeni na Amani Street, Geita Town in Geita Region. During inspection, it was observed that Enocy Shop was conducting LPG distribution business at Nendeni na Amani Street, Geita Town in Geita Region without a licence from EWURA contrary to section 131(1) of the Petroleum Act, Cap. 392 and Rule 8(1) of the Petroleum (Liquified Petroleum Gas Operations) Rules, 2020. The culprit was also found in possession of LPG gas cylinders of different sizes from different brands including MANJIS Logistics Limited.

It is on record that EWURA through its letter Ref. No. BA. 308/493/14/Vol.1/49 dated 17th July 2023 ordered **Manjis Logistics Limited** to stop supplying LPG cylinders to Enocy Shop & General Supply. Despite our directive, you still supply LPG cylinders to Enocy Shop contrary to EWURA directives.

Pursuant to Section 240(1)(f) of The Petroleum Act, Cap. 392, Manjis logistics Limited as an LPG Wholesaler is, at all times, required to abide to EWURA directives and Orders and failure to do so is punishable in law.

ORDER

THEREFORE, and based on the foregoing EWURA has considered the matter in accordance with the applicable laws and has decided that Manjis Logistics Limited be and is HEREBY ORDERED to:

- a) immediately stop supplying LPG cylinders to Enocy Shop & General Supply; and
- b) explain in writing within seven (7) days from the date of receipt of this Order why legal action should not be taken against **Manjis Logistics Limited** for failure to comply with EWURA directives and Orders.
