**PRELIMINARIES**

On 11<sup>th</sup> to 13<sup>th</sup> September 2024, EWURA conducted a compliance monitoring inspection at PanAfrican Energy Limited (PAET) natural gas distribution network. During the inspection, it was noted that PAET had signed a Gas Sales Agreement with **TAN HEALTH Limited** located at Oyster Pearl Galleria, Office 209, 2<sup>nd</sup> floor, 6 Chole Road, Oyster Bay, Dar es Salaam and the latter having a CNG supply contract with Anric Gas Technology (T) Co. Ltd without a CNG Supply Licence contrary to Section 131(1) of the Petroleum Act, Cap. 392 and Rule 8 of the Petroleum (Compressed Natural Gas) (Supply and Marketing Service)) Rules, 2019 which prohibits undertaking of a CNG activity without obtaining a licence from the Authority.

**ORDER**

Therefore, and based on the foregoing EWURA has considered the matter in accordance with the applicable law and has decided that TAN HEALTH Limited be and is **HEREBY ORDERED** to:

- (a) immediately stop undertaking any CNG transportation and supply activities; and
- (b) explain in writing within fourteen (14) days from the date of receipt of this Order why legal action should not be taken against you for conducting CNG supply activities without obtaining a licence from EWURA, as required by Section 131(1) of the Petroleum Act, Cap. 392 and Rule 8 of the Petroleum (Compressed Natural Gas) (Supply and Marketing Service)) Rules, 2019;
