PRELIMINARIES

Bageni Company Limited is a licensed wholesaler mandated to conduct petroleum wholesale business in Tanzania. EWURA conducted an audit exercise on your operations by assessing your petroleum products stock movement from 1st January 2023 to 31st December 2023 to establish compliance with the applicable law and regulations.

FINDINGS

During the audit, EWURA noted with concern that Bageni Company Limited:

- (a) purchased petroleum products from Hass Petroleum Limited which is also a licensed wholesaler contrary to rule 26 of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, 2022; and
- (b) sold petroleum products below the wholesale floor price contrary to rule 6(a)(iii) of the EWURA Petroleum Products Price Setting Rules, 2022 as indicated in the Annex.



ORDER

Therefore, and based on the foregoing, EWURA has considered the matter in accordance with the applicable law and decided that Bageni Company Limited be and is HEREBY ORDERED to:

- a) stop purchasing petroleum products from other licensed wholesalers;
- sale petroleum products using approved prices; and b)
- explain in writing within seven (7) days from the date of receipt of this Order c) why legal action should not be taken against Bageni Company Limited for contravening the above cited provisions of the law.
