PRELIMINARIES

As a matter of background, on 29th June 2024, EWURA closed Kanyigo Filling Station located at Kanyigo Area, Missenyi District in Kagera Region for selling petroleum products above cap price contrary to Rule 6(a)(iii) of the EWURA Petroleum Products Price Setting Rules, 2022 and operating without a licence by affixed a seal thereon. Consequently, Compliance Order No. 11.07.2024 to that effect was issued and served upon you. However, on 8th January 2025, EWURA observed that you tampered with EWURA seals at the retail outlet and resumed operations. Tempering with EWURA seals is contrary to Section 39(2) of the EWURA Act, Cap. 414, Section 240 (1)(vi) of the Petroleum Act, Cap. 392 and rule 56 of the Petroleum (Wholesale, Storage, Retail and Consumer Installations Operations) Rules, 2022.

ORDER

THEREFORE, and based on the foregoing EWURA has considered the matter in accordance with the applicable law and has decided that Kanyigo Filling Station located at Kanyigo Area, Missenyi District in Kagera Region be and is HEREBY ORDERED to:

(a) immediately stop undertaking any petroleum operations at the retail outlet located at Kanyigo Area, Missenyi District in Kagera Region; and

(b) explain in writing within seven (7) days from receiving this Order why legal action should not be taken against you for tempering with EWURA seals contrary to Section 39(2) of the EWURA Act, Cap. 414, section 240 (1)(vi) of the Petroleum Act, Cap. 392 and Rule 56 of the Petroleum (Wholesale, Storage, Retail, and Consumer Installations Operations) Rules, 2022.
