PRELIMINARIES

EWURA while conducting a sales audit exercise in order to establish compliance with the applicable law and regulations noted with concern that between 1st November 2022 to 31st October 2023, Dalbit Petroleum Ltd a wholesaler with Licence No. PWL-2022-008 with its registered office located at the 3rd Floor Jamana House, Pugu Road in Dar es Salaam Region has been acting contrary to the applicable law.

FINDINGS

During the audit exercise by assessing petroleum products stock movement from 1st November 2022 to 31st October 2023, EWURA established that Dalbit Petroleum Ltd:

- (a) Stored petroleum products at unlicensed depots and sold petroleum products to unlicensed buyers as per **Annex 1** contrary to rule 25(2)(a)(i) of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, GN No. 150 of 2022; and
- (b) selling petroleum products above or below the cap price contrary to Rule 6(a) (ii) and (iii) of the EWURA Petroleum Products Price Setting Rules, GN No. 57 of 2022 as indicated in **Annex 2**.



(c) Submitted inaccurate data that indicated sales made by Dalbit Petroleum Ltd were higher than available stock as detailed in **Annex 3** contrary to section 240(1)(b) of the Petroleum Act, Cap 392.

ORDER

Therefore, and based on the foregoing, EWURA has considered the matter in accordance with the applicable law and decided that **Dalbit Petroleum Limited** be and is **HEREBY ORDERED** to:

- a) immediately stop selling or offering for sale Petroleum Products to unlicensed persons;
- b) immediately stop selling petroleum products using un-approved prices and ensure at all times you sell petroleum products using approved wholesale cap price pursuant to Rule 6(a) (ii) and (iii) of the EWURA Petroleum Products Price Setting Rules, GN No. 57 of 2022; and;
- c) explain in writing within seven (7) days from the date of receipt of this Order why legal action should not be taken against Dalbit Petroleum Limited for contravening the above provisions of law and licence terms and conditions.
