PRELIMINARIES

By virtue of the inspection conducted on 18th July, 2024, EWURA has noted with concern that Francis Boniface Chacha T/A Kinesi Filling Station located at Kinesi Village, Rorya District in Mara Region is operating the petroleum facility without seeking and obtaining a licence from EWURA, contrary to section 131(1) of the Petroleum Act, Cap. 392 and Rule 10 of the Petroleum (Retail Operations in Townships and Villages) Rules, 2020, which requires a person to obtain a licence before conducting any petroleum operations. Operating a petroleum products installation without a licence from EWURA contravenes the law and is punishable as such

ORDER

Therefore, and based on the foregoing EWURA has considered the matter in accordance with the applicable law and has decided that Francis Boniface Chacha T/A Kinesi Filling Station be and is **HEREBY ORDERED** to:



- (a) immediately stop undertaking any petroleum operations at your facility located at Kinesi Village, Rorya District in Mara Region; and
- (b) explain in writing within seven (7) days from receipt of this Order why legal action should not be taken against you for operating a petroleum retail station without obtaining a licence from EWURA, as required by section 131(1) of the Petroleum Act, Cap. 392 and Rule 4(1) of the Petroleum (Retail Operations in Townships and Villages) Rules, 2020.
