#### **PRELIMINARIES**

EWURA has noted that Francis Boniphace Chacha has constructed a petroleum installation facility at Kinesi Village, Rorya District in Mara Region without having applied and obtained construction approval from EWURA contrary to section 127(1) of the Petroleum Act, Cap. 392 and Rule 4(1) of the Petroleum (Wholesale, Storage, Retail, and Consumer Installation) Rules, GN. No. 150 of 2022. (See the attached Photo). The cited provisions of the law oblige any person intending to construct a petroleum installation facility to apply and obtain construction approval from EWURA.

Constructing a petroleum installation facility without obtaining construction approval from EWURA is an offence punishable under the law.

#### **ORDER**

THEREFORE, and based on the foregoing EWURA has considered the matter in accordance with the applicable laws and has decided that Francis Francis Boniphace Chacha located at Kinesi Village, Rorya District in Mara Region be and IS HEREBY ordered to:

- a) immediately stop any petroleum operation at the petroleum facility located at Kinesi
   Village, Rorya District in Mara Region and;
- b) explain in writing within seven (7) days from the date of receipt of this Order why severe punishment should not be taken against **Fransis Boniphace Chacha** for the construction of a petroleum facility without obtaining a construction approval from EWURA contrary to section 127(1) of the Petroleum Act, Cap. 392 and Rule 4(1) of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, GN. No. 150/2022.
