PRELIMINARIES

EWURA has noted with concern that on 9th August 2024 at approximately 11:20 hours, an incident occurred at Gapco (T) Ltd – Uhuru Peak Service Station located at Plot No. 32, Block "Z", Kibo Road, Moshi Municipality in Kilimanjaro Region with licence number PRL-2018-350. The incident involved a 21-year-old male named Shalom Albert Tarimo, who died in an automotive gas oil (AGO) storage tank.

FINDINGS

On 10th August 2024, EWURA conducted an investigation on the matter and noted that:

(a) during routine calibration of the facility's underground petroleum storage tanks, GAPCO (T) Ltd did not take enough precautionary measures to avoid accident including restriction of unauthorized personnel and thus the company was in total breach of the applicable codes and standards on safety, security, health, and environment applicable during calibration contrary to rule 25 (1) (a) (vi) and 27 (1) (a) of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) GN 150 of 2022. (b) after the incident, Gapco (T) Ltd - Uhuru Peak Service Station did not notify the Authority on the incident contrary to rule 25 (c) of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) GN 150 of 2022.

ORDER

THEREFORE, and based on the foregoing EWURA has considered the matter in accordance with the applicable laws and has decided that Gapco (T) Ltd - Uhuru Peak Service Station located at Plot No. 32, Block "Z", Kibo Road, Moshi Municipality in Kilimanjaro Region be and IS HEREBY ORDERED to explain in writing within seven (7) days from the date of receipt of this Order why severe punishment should not be taken against the company for contravening the above provisions of law.






Figure 1: Overview of the area after the incident
