PRELIMINARIES

Hass Petroleum Limited (Hass) is a licensed wholesaler mandated to conduct petroleum wholesale business in Tanzania. EWURA conducted an audit exercise on your operations by assessing your petroleum products stock movement from 1st November 2022 to 31st October 2023 to establish compliance with the applicable laws and regulations.

FINDINGS

During the audit, EWURA noted with concern that Hass Petroleum Limited:

- (a) sold petroleum products to unlicensed customers contrary to Rule 25(2)(a)(i) of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations)
 Rules, 2022 as indicated in *Annex 1*;
- (b) sold petroleum products below the wholesale floor price or above the cap price contrary to Rule 6(a)(iii) of the EWURA Petroleum Products Price Setting Rules, 2022 as indicated in *Annex* 2; and
- (c) submitted inaccurate data contrary to Section 240(1)(b) of the Petroleum Act, Cap 392 where there was significant variation of the reported closing stock as per *Annex 3*. Our emails requiring clarification on the discrepancy received no response.

ORDER

Therefore, and based on the foregoing, EWURA has considered the matter in accordance with the applicable law and decided that Hass Petroleum Limited be and is **HEREBY ORDERED** to:

- a) stop selling petroleum products to unlicensed customers;
- b) sale of petroleum products using approved prices; and
- c) explain in writing within seven (7) days from the date of receipt of this Order why legal action should not be taken against Hass Petroleum Limited for contravening the above-cited law provisions.
