PRELIMINARIES

Infinity Oil Company Limited is a licensed wholesaler mandated to conduct petroleum wholesale business in Tanzania. EWURA conducted an audit exercise on your operations by assessing your petroleum products stock movement from 1st November 2022 to 30th October 2023 to establish compliance with the applicable laws and regulations.

FINDINGS

During the audit, EWURA noted with concern that Infinity Oil Company Limited sold petroleum products above or below the cap price contrary to rule 6(a) (iii) of the EWURA Petroleum Products Price Setting Rules, 2022 as indicated in the *Annex*. Despite several reminders, you did not submit copies of the invoices for the transactions that are not within the approved prices.

ORDER

Therefore, and based on the foregoing, EWURA has considered the matter in accordance with the applicable law and decided that Infinity Oil Company Limited be and is **HEREBY ORDERED** to:

- a) immediately stop selling petroleum products using un-approved prices; and
- b) explain in writing within seven (7) days from the date of receipt of this Order why legal action should not be taken against Infinity Oil Company Limited for contravening the above provisions of law and the licence terms and conditions.
