PRELIMINARIES

EWURA has noted with concern that Juma George Magere has constructed a petroleum retail outlet at Igingilanyi Village, Iringa District in Iringa Region without obtaining a construction approval from EWURA contrary to Section 127(1) of the Petroleum Act, Cap. 392 and Rule 4(1) of the Petroleum (Retail Operations in Townships and Villages) (Amendment) Rules, GN. No. 818 of 2020. (See the attached Photo). The cited provisions obligate and compel any person intending to construct a petroleum facility including petroleum retail outlets to apply and obtain construction approval from EWURA before starting construction.

Constructing a petroleum facility without obtaining construction approval from EWURA is punishable under the law.

ORDER

THEREFORE, and based on the foregoing EWURA has considered the matter in accordance with the applicable laws and has decided that Juma George Magere located at Igingilanyi Village, Iringa District in Iringa Region be and IS HEREBY ordered to:



- (a) immediately stop the ongoing construction activities at **Igingilanyi Village**, **Iringa District in Iringa Region**; and
- (b) explain in writing within seven (7) days from the date of receipt of this Order why severe punishment should not be taken against Juma George Magere for constructing of a petroleum facility at Igingilanyi Village, Iringa District in Iringa Region without obtaining construction approval from EWURA contrary to Section 127(1) of the Petroleum Act, Cap. 392 and Rule 4(1) of the Petroleum (Retail Operations in Townships and Villages) (Amendment) Rules, GN. No. 818 of 2020.
