### **PRELIMINARIES**

EWURA has noted with concern that Karagwe Oils Company Limited has constructed a petroleum retail outlet Plot No. 21, Block "A", Bukombe Village, Bukombe District in Geita Region without obtaining a construction approval from EWURA contrary to section 127(1) of the Petroleum Act, Cap. 392 and rule 4(1) of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, G.N. No 150 of 2022. (See the attached Photo). The cited provisions obligate and compel any person intending to construct a petroleum facility including petroleum retail outlet to apply and obtain construction approval from EWURA prior to starting construction.

Constructing a petroleum facility without obtaining construction approval from EWURA is an offence punishable under the law.

#### <u>ORDER</u>

THEREFORE, and based on the foregoing EWURA has considered the matter in accordance with the applicable laws and has decided that Karagwe Oils Company Limited located at Plot No. 21, Block "A", Bukombe Village, Bukombe District in Geita Region be and IS HEREBY ordered to:

- a) immediately stop the ongoing construction activities at Plot No. 21, Block "A",
   Bukombe Village, Bukombe District in Geita Region; and;
- b) explain in writing within seven (7) days from the date of receipt of this Order why severe punishment should not be taken against **Karagwe Oils Company Limited** for constructing of a petroleum retail outlet at Plot No. 21, Block "A", Bukombe Village, Bukombe District in Geita Region without obtaining construction approval from EWURA contrary to section 127(1) of the Petroleum Act, Cap. 392 and rule 4(1) of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, G.N. No 150 of 2022.


