PRELIMINARIES

On 5th June 2024, EWURA noted that Lake Oil Limited T/A Lake Oil Limited Chumbageni Tanga with petroleum retail outlet located at Plot No. 671/16, Block "KBV", Chumbageni Area, Chumbageni Ward in Tanga Region with petroleum retail licence No. PRL-2023-415 was selling petroleum products above cap price contrary to Rule 6 (a) (iii) of the EWURA Petroleum Products Price Setting Rules, GN No.57 of 2022. Lake Oil Limited T/A Lake Oil Limited Chumbageni Tanga was selling petroleum products (Petrol) at the price of TZS 3,220 per litres which is above the published cap price of TZS 3,210 per litres (**EFPP receipt attached**).

ORDER

Therefore, and based on the foregoing, EWURA has considered the matter in accordance with the applicable law and decided that Lake Oil Limited T/A Lake Oil Limited Chumbageni Tanga be and is **HEREBY ORDERED** to:

- a) stop immediately selling or offering for sale Petroleum Products above cap price;
and

- b) explain in writing within seven (7) days from the date of receipt of this Order why legal action should not be taken against Lake Oil Limited T/A Lake Oil Limited Chumbageni Tanga for contravening the above provisions of law and licence terms and conditions.
