IN THE MATTER OF CHECKING ON COMPLIANCE WITH THE REQUIREMENT TO MAINTAIN A MINIMUM STOCK OF PETROLEUM PRODUCTS BY MADEMA CO. LIMITED – USEVYA FILLING STATION

PRELIMINARIES

On 7th January 2025, EWURA inspected Madema Co. Limited – Usevya Filling Station located in Mpimbwe District to check on compliance with the requirement to maintain a minimum stock of petroleum products by retailers. EWURA noted with the concern that the retail outlet was having neither petrol nor diesel stock. Through the NPGIS data submitted by the outlet, it is established that your daily sales are 1749 litres of petrol and 1690 litres of diesel. Having no petroleum products stock is contrary to rule 25(2)(b)(iii) of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, 2022 which requires a retailer to ensure that, at all times, it maintains a minimum stock level of at least three (3) days.

ORDER

Therefore, and based on the foregoing, and in accordance with the applicable law, EWURA has decided that Madema Co. Limited – Usevya Filling Station located at Mpimbwe District be and is hereby **ORDERED** to:

- (a) immediately stop undertaking petroleum operations at Madema Co. Limited – Usevya Filling Station located at Mpimbwe District; and
- (b) explain in writing within seven (7) days from the date of receipt of this Order as to why legal action should not be taken against you for failure to maintain minimum stock of at least three days.
