PRELIMINARIES

EWURA has noted with concern that Matiko Silas Maisa t/a Muriba Oil located at Muriba Village, Tarime District in Mara Region has constructed a petroleum installation facility without having applied and obtained construction approval from EWURA. This contravenes the provisions of section 127(1) of the Petroleum Act, Cap. 392 and rule 4(1) of the Petroleum (Retail Operations in Townships and Villages) Rules, GN. No. 818 of 2020 requires any person intending to construct a petroleum installation facility to apply and obtain construction approval from EWURA. **(See the attached photo)**

Constructing a petroleum installation facility without obtaining construction approval from EWURA is contrary to the law and punishable as such.

ORDER

THEREFORE, and based on the foregoing EWURA has considered the matter in accordance with the applicable laws and has decided that **Matiko Silas Maisa t/a Muriba Oil Petrol Station** located at **Muriba Village, Tarime District in Mara Region** be and **IS HEREBY** ordered to:

- a) immediately stop ongoing construction activities at **Muriba Village, Tarime District in Mara Region** until you obtain a construction approval from EWURA; and
- b) explain in writing within seven (7) days from the date of receipt of this Order why severe punishment should not be taken against **Matiko Silas Maisa t/a Muriba Oil Petrol Station** located at **Muriba Village, Tarime District in Mara Region** for the construction of a petroleum retail outlet without applying or obtaining construction approval from EWURA contrary to Section 1271(1) of the Petroleum Act, Cap. 392 and Rule 4(1) of the Petroleum (Retail Operations in Townships and Villages) Rules, GN. No. 818 of 2020.
