PRELIMINARIES

On 15th July 2024, EWURA noted that Sudi Moshi Mrisho T/A Mapito Filling Station-Kibaoni located Plot No. 117, Block "G", Uvinza Minor Settlement, Uvinza District in Kigoma Region was selling petroleum products above cap price contrary to Rule 6(a)(iii) of the EWURA Petroleum Products Price Setting Rules, 2022. The retail outlet was selling petrol at the price of TZS 3513 per litre which is above the published cap price of TZS 3,363 per litre.

ORDER

Therefore, and based on the foregoing, EWURA has considered the matter in accordance with the applicable law and decided that Sudi Moshi Mrisho T/A Mapito Filling Station-Kibaoni located Plot No. 117, Block "G", Uvinza Minor Settlement, Uvinza District in Kigoma Region be and is **HEREBY ORDERED** to:

- a) Immediately stop selling or offering for sale petroleum products above cap price; and

- b) explain in writing within seven (7) days from the date of receipt of this Order why legal action should not be taken against Sudi Moshi Mrisho T/A Mapito Filling Station- Kibaoni located Plot No. 117, Block "G", Uvinza Minor Settlement, Uvinza District in Kigoma Region for contravening the above provisions of law and licence terms and conditions.
