NOTICE is hereby given to the public that, EWURA has received an application from **Tanzania Petroleum Development Cooperation (TPDC)** seeking **Construction Approval** for the construction of 250m long and eight (8) inch diameter steel pipe along Goba road using Songas Limited wayleave. The proposed pipeline will be supplying natural gas to Tanstate Holdings Natural Gas Company CNG Mother station located at Goba ward, Kinondoni Municipality, Dar es Salaam Region. The project contractor for this construction is SGR Petropower Engineering Tanzania Limited.
