PUBLIC NOTICE

A CALL FOR STAKEHOLDERS' VIEWS ON AUTOMATIC WATER TARIFF ADJUSTMENT APPLICATION FROM MAGANZO WATER SUPPLY AND SANITATION AUTHORITY (MAGANZO WSSA) FOR YEAR 2018/19 – 2020/21

On 26th February 2019, The Energy and Water Utilities Regulatory Authority (EWURA) has received Automatic Water Supply Adjustment Application from Maganzo Water Supply and Sanitation Authority. The Application is based on the change in bulk water tariff from Kahama Shinyanga Water Supply and Sanitation Authority (KASHWASA) which increased by 38% and became effective 1st January 2019. The Tables below present the summary of the existing and proposed tariffs and fees.
