PUBLIC NOTICE

A CALL FOR STAKEHOLDERS' VIEWS ON THE TARIFF APPLICATION FROM KILINDONI URBAN WATER SUPPLY AND SANITATION AUTHORITY ("KILINDONI WSSA") FOR YEAR 2019/20 – 2021/22

Tariff Application No. TR-W-18-025

On 17th November 2018 the Energy and Water Utilities Regulatory Authority (EWURA) received a Tariff Application from Kilindoni Urban Water Supply and Sanitation Authority (Kilindoni WSSA) requesting for a multiyear tariff adjustment for water services. According to Kilindoni WSSA, the main justification for tariff review application is to meet the current and future operational and maintenance costs which have increased tremendously since the last tariff review in June 2011.

Pursuant to sub-section 19(2) (b) of the EWURA Act, Cap 414, there shall be a public inquiry meeting on **Thursday, 23rd May 2019 at Mafia Prison Hall (Magereza Hall), Kilindoni Town** from **10:00hrs** to collect views of stakeholders including Government Consultative Council (GCC), Consumer Consultative Council (CCC) and the general public on the reasonableness of the proposed tariff application.

Those who wish to submit written comments on the reasonableness of the proposed tariffs and charges are invited to do so by writing to the Director General using the above-mentioned address at any time by **30th May 2019**.
