IN THE MATTER OF ROUTINE INSPECTION AT RETAIL OUTLETS

AND

IN THE MATTER OF CHECKING ON COMPLIANCE TO CONSTRUCTION APPROVAL REQUIREMENTS AT RETAIL OUTLETS AT JAFARI GUKA – SAMBWE FILLING STATION LOCATED AT SAMBWE VILLAGE AREA, KONDOA DISTRICT IN DODOMA REGION.

(Made under section 39 of the EWURA Act, Cap. 414 and section 127 (1) of the Petroleum Act, Cap. 392)

PRELIMINARIES

EWURA has noted with concern that you are constructing a petrol station without having applied and obtained a construction approval from EWURA contrary to section 127 (1) of the Petroleum Act, Cap.392 and Rule 4 of the Petroleum (Retail Operations) Rules, GN.No.168 of 2015, which require any person intending to construct a petroleum installation facility to obtain a construction approval before construction of the same. Constructing a petroleum installation facility without obtaining a construction approval from EWURA contravenes the law and is punishable as such.

ORDER

Therefore, and based on the foregoing EWURA has considered the matter in accordance with the applicable law and has decided that Jafari Guka – Sambwe Filling Station located at Sambwe Village Area, Kondoa District in Dodoma Region be and is HEREBY ORDERED to:

(a) immediately stop the on-going construction at your facility located at **Sambwe Village Area, Kondoa District** in **Dodoma Region**; and

(b) explain in writing within seven (7) days from the date of receipt of this Order why severe punishment should not be taken against you for undertaking construction of a retail outlet without obtaining a construction approval from EWURA.
