PRELIMINARIES

EWURA has noted with concern that your petrol station was constructed without applying for construction approval from the Authority contrary to section 13 (1) of the Petroleum Act, Cap. 392 and Rule 4 of the Petroleum (Retail Operations) Rules, GN.No.418 of 2012, which require any person intending to construct a petroleum installation facility to apply for construction approval before construction of the same. Constructing a petroleum installation facility without obtaining a construction approval from EWURA contravenes the law and is punishable as such.

ORDER

THEREFORE and based on the foregoing EWURA has considered the matter in accordance with the applicable law and has decided that **NSAGALI PETROL STATION - SIMIYU** located at Lamadi Area in Simiyu Region be and is **HEREBY ORDERED** to:

- (a) immediately stop undertaking the ongoing construction at your facility located at Lamadi Area in Simiyu Region; and
- (b) explain in writing within seven (7) days from the date of receipt of this Order why severe punishment should not be taken against it for undertaking construction of a retail outlet without obtaining a construction approval from EWURA.
