**IN THE MATTER OF ROUTINE INSPECTION AT RETAIL OUTLETS**

**AND**

**IN THE MATTER OF CHECKING ON COMPLIANCE TO  
CONSTRUCTION APPROVAL AND LICENSING REQUIREMENTS AT  
RETAIL OUTLETS AT TSN OIL (T) LTD- SONGEA CHANGARAWE  
PETROL STATION LOCATED AT TUNDURU STREET, SONGEA  
MUNICIPALITY IN RUVUMA REGION**

**(COMPLIANCE ORDER NO: 18-03-2019)**

**(Made under section 39 of the EWURA Act, Cap. 414, sections 127(1) and  
131 (1) of the Petroleum Act, Cap. 392)**

**PRELIMINARIES**

EWURA has noted with concern that you have constructed a petrol station without having applied and obtained a construction approval from EWURA contrary to section 127 (1) of the Petroleum Act, Cap.392 and Rule 4 of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, GN. No. 380 of 2018, which require any person intending to construct a petroleum installation facility to obtain a construction approval before commencing construction of the same. Constructing a petroleum installation facility without obtaining a construction approval from EWURA contravenes the law and is punishable as such.

Furthermore, TSN Oil (T)Ltd – Songea Changarawe Petrol Station is operating a retail outlet located at Tunduru Street, Songea Municipality in Ruvuma Region without applying and obtaining a petroleum retail licence from EWURA contrary to section 131 (1) of the Petroleum Act, Cap.392 and Rule 10 of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, GN. No. 380 of 2018, which require any person intending to operate a petroleum retail outlet to obtain a licence from EWURA. Operating a petroleum retail outlet without obtaining a licence from EWURA contravenes the law and is punishable as such.

**ORDER**

Therefore, and based on the foregoing, EWURA has considered the matter in accordance with the applicable law and has decided that **TSN Oil (T)Ltd – Songea Changarawe Petrol Station** located at **Tunduru Street, Songea Municipality in Ruvuma Region** be and is **HEREBY ORDERED** to:

- (a) immediately stop undertaking petroleum operations at your facility located at Tunduru Street, Songea Municipality in Ruvuma Region; and
- (b) explain in writing within seven (7) days from the date of receipt of this Order why severe punishment should not be taken against you for:
  - (i) undertaking construction of a retail outlet without obtaining a construction approval from EWURA contrary to section 127(1) of the Petroleum Act, Cap 392 and Rule 4 of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, GN. No. 380 of 2018; and
  - (ii) operating a retail outlet without a licence from EWURA contrary to section 131 (1) of the Petroleum Act, Cap.392 and Rule 10 of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, GN.No.380 of 2018.
