IN THE MATTER OF ROUTINE INSPECTION AT RETAIL OUTLETS

AND

IN THE MATTER OF CHECKING ON COMPLIANCE TO CONSTRUCTION APPROVAL REQUIREMENTS AT RETAIL OUTLETS AT AHMED M. SHABIBY PETROL STATION LOCATED AT PLOT NO. 45, BLOCK 5, NALA AREA, IN DODOMA REGION.

(Made under section 39 of the EWURA Act, Cap. 414 and section 127 (1) of the Petroleum Act, Cap. 392)

## **PRELIMINARIES**

EWURA has noted with concern that you have constructed a petrol station without having applied and obtained a construction approval from EWURA contrary to section 127 (1) of the Petroleum Act, Cap.392 and Rule 4 (1-3) of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, GN.No. 168 of 2015, which require any person intending to construct a petroleum installation facility to obtain a construction approval before construction of the same. Constructing a petroleum installation facility without obtaining a construction approval from EWURA contravenes the law and is punishable as such.

## **ORDER**

Therefore, and based on the foregoing EWURA has considered the matter in accordance with the applicable law and has decided that Ahmed M. Shabiby Petrol Station located at Plot No.45, Block 5, Nala Area in Dodoma Region be and is HEREBY ORDERED to:

 (a) immediately stop the on-going construction and undertaking petroleum operations at your facility located at Plot No.45, Block 5
 Nala Area in Dodoma Region; and (b) explain in writing within seven (7) days from the date of receipt of this Order why severe punishment should not be taken against you for undertaking construction of a retail outlet without obtaining a construction approval from EWURA.
