# IN THE MATTER OF ROUTINE INSPECTION AT RETAIL OUTLETS

### AND

IN THE MATTER OF CHECKING ON COMPLIANCE TO CONSTRUCTION APPROVAL REQUIREMENTS AT RETAIL OUTLETS AT ARIZONA INTERPRISE - ITIGI FILLING STATION LOCATED AT ITIGI AREA, MANYONI DISTRICT IN SINGIDA REGION.

# (COMPLIANCE ORDER NO: 10-11-2018) REFERENCE NO: BA.306/369/2146/2

(Made under section 39 of the EWURA Act, Cap. 414 and section 127 (1) of the Petroleum Act, Cap. 392)

## **PRELIMINARIES**

EWURA has noted with concern that you have constructed a petrol station without having applied and obtained a construction approval from EWURA contrary to section 127 (1) of the Petroleum Act, Cap.392 and Rule 4 of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, GN.No. 168 of 2015, which require any person intending to construct a petroleum installation facility to obtain a construction approval before commencing construction of the same. Constructing a petroleum installation facility without obtaining a construction approval from EWURA contravenes the law and is punishable as such.

### ORDER

Therefore, and based on the foregoing EWURA has considered the matter in accordance with the applicable law and has decided that **Arizona Interprise**-Itigi Filling Station located at Itigi Area, Manyoni District in Singida Region be and is HEREBY ORDERED to:

 (a) immediately stop the on-going construction and undertaking petroleum operations at your facility located at Itigi Area, Manyoni District in Singida Region; and (b) explain in writing within seven (7) days from the date of receipt of this Order why severe punishment should not be taken against you for undertaking construction of a retail outlet without obtaining a construction approval from EWURA.
