# IN THE MATTER OF ROUTINE INSPECTION AT RETAIL OUTLETS

#### AND

IN THE MATTER OF CHECKING ON COMPLIANCE TO CONSTRUCTION APPROVAL AND LICENSING REQUIREMENTS AT RETAIL OUTLETS BY OILCOM (T) LIMITED LOCATED AT PLOT 8-13, BLOCK 'B' CENTRE KISASA AREA, DODOMA MUNICIPALITY IN DODOMA REGION.

## **PRELIMINARIES**

EWURA has noted with concern that you have constructed a petrol station without having applied and obtained a construction approval from EWURA contrary to section 127 (1) of the Petroleum Act, Cap.392 and Rule 4 of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, GN. No. 380 of 2018, which require any person intending to construct a petroleum installation facility to obtain a construction approval before commencing construction of the same. Constructing a petroleum installation facility without obtaining a construction approval from EWURA contravenes the law and is punishable as such.

#### **ORDER**

Therefore, and based on the foregoing EWURA has considered the matter in accordance with the applicable law and has decided that the petrol station by Oilcom (T) Limited located at Plot 8-13, Block B, Centre Kisasa Area, Dodoma Municipality in Dodoma Region be and is HEREBY ORDERED to:

(a) immediately stop ongoing construction and or undertaking petroleum operations at your facility located at Plot 8-13, Block B, Centre Kisasa Area, Dodoma Municipality in Dodoma Region; and

(b) explain in writing within seven (7) days from the date of receipt of this Order why severe punishment should not be taken against you for undertaking construction of a retail outlet at Plot 8-13, Block B, Centre Kisasa Area, Dodoma Municipality in Dodoma Region without obtaining a construction approval from EWURA contrary to section 127(1) of the Petroleum Act, Cap 392 and rule 4 of the Petroleum (Wholesale, Storage, Retail and Consumer Installation Operations) Rules, GN. No. 380 of 2018.
