PUBLIC NOTICE ON CAP PRICES FOR PETROLEUM PRODUCTS EFFECTIVE WEDNESDAY, 3rd MAY 2017

The Energy and Water Utilities Regulatory Authority (EWURA) hereby publishes cap petroleum products prices, applicable in Tanzania Mainland. These retail and wholesale prices are applicable effective **Wednesday**, 3rd May 2017. Furthermore, kindly, take note of the following:

- (a) Retail and wholesale prices for petrol, diesel and kerosene have changed compared to prices that were published on 5th April 2017. Retail prices of Petrol, Diesel and Kerosene have decreased by TZS 31/litre (equivalent to 1.48%), TZS 80/litre (equivalent to 4.18%) and TZS 16/Litre (equivalent to 0.88%), respectively. Similarly, compared to the last month publications, wholesale prices for Petrol, Diesel and Kerosene have also decreased by TZS 30.50/litre (equivalent 1.57%), TZS 80.42/litre (equivalent to 4.43%) and TZS 16.31/Litre (equivalent to 0.93%), respectively. The reductions in local pump prices have been caused largely by decreases in world oil market prices and a slight appreciation of the Tanzania Shilling against the US dollar, the currency used to procure petroleum products.
- (b) Retail and wholesale prices of Petrol and Diesel for Tanga Region have also decreased compared to prices that were published on 5th April 2017. Kerosene prices remain unchanged due to the fact that there were no new consignment of kerosene imported in the month of April 2017 through Tanga port. Retail prices for Petrol and Diesel have decreased by TZS 127/litre (about 6.10%) and TZS 86/litre (about 4.40%), respectively. Likewise, wholesale prices for Petrol and Diesel have decreased by TZS 127.44/litre (about 6.44%) and TZS 85.57/litre (about 4.67%), respectively. As highlighted before, the decrease in local pump prices is attributed to the decreases in world oil market prices and premiums coupled with a slight appreciation of the Tanzania Shilling against the US dollar, the currency used for procurement of petroleum products. Furthermore, it should be noted that the reductions in Tanga's prices are higher than Dar es salaam's prices due to the fact that there were no new consignment imported in Tanga in March 2017.
- (c) The Authority would like to remind the public that these cap prices can be accessed through mobile phones by dialling *152*00# and then following the provided instructions. This service is free of charge and is available in all mobile phone service providers in the country.
- (d) In line with the prevailing sector legislation (**Petroleum Act,2015**, section 166), prices of petroleum products are governed by rules of demand and supply. EWURA shall continue to encourage competition in the sector by making available petroleum products pricing information including cap prices. This information on prices is intended to enable stakeholders make informed decisions on petroleum prices at any particular time.

- (e) Oil Marketing Companies are free to sell their products at a price that gives them a competitive advantage provided that, such price does not exceed the price cap for the relevant product as was computed using the approved formula, which was gazetted through the Government Notice No. 70 published on 12 February 2016.
- (f) All petrol stations are required to publish petroleum product prices on clearly visible boards. The price boards should be clearly visible and should clearly show prices charged, discounts offered as well as any trade incentives or promotions on offer. Consumers are advised to purchase from stations that sell products at the most competitive prices. It is an offence not to have prices published on boards located in clearly visible places in front of petrol stations and it will attract punitive measures from EWURA.
- (g) Retailers must issue receipts with respect to all sales that they make and consumers are required to **demand and keep receipts** that clearly show the name of petrol station, date on which such purchase was made as well as, the type of fuel and price per litre for every purchase they make. This can be used as an exhibit in case of a complaint lodged in the event that the selling price is above the cap price or in case the products sold do not meet the approved specifications.
