**PUBLIC NOTICE ON CAP PRICES FOR PETROLEUM PRODUCTS EFFECTIVE
WEDNESDAY, 5th APRIL 2017**

The Energy and Water Utilities Regulatory Authority (EWURA) hereby publishes cap petroleum products prices, applicable in Tanzania Mainland. These retail and wholesale prices are applicable effective **Wednesday, 5th April 2017**. Furthermore, kindly, take note of the following:

- (a) Retail and wholesale prices for petrol, kerosene and diesel have changed compared to prices that were published on 1st March 2017. The retail price for petrol has decreased by TZS 3/litre, equivalent to 0.13%; while its wholesale price has decreased by TZS 5.65/litre equivalent to 0.29%. The diesel retail price has increased by TZS 12/litre, equivalent to 0.63%, while its wholesale price has increased by TZS 9.11/litre equivalent to 0.50%. On the other hand, the retail price for kerosene has increased by TZS 7/litre or 0.36% while the wholesale price has increased by TZS 3.68/litre or 0.21%. Changes in prices of the three petroleum products are to a larger extent due to changes in prices of these products in world oil market, changes in BPS premiums and annual inflationary adjustments.
- (b) There was no new consignment of petroleum products received through Tanga port during the month of March 2017. However, there are slight change in the prices of petrol, diesel and kerosene due to an increase in wholesalers' and retailers' margins on account of annual inflation adjustment. Retail prices for Petrol, Diesel and Kerosene have increased by TZS 7/litre or 0.32%, TZS 7/litre or 0.34%, and TZS 7/litre or 0.44%, respectively. Likewise, wholesale prices for Petrol, Diesel and Kerosene have increased by TZS 3.68/litre or 0.19%, TZS 3.68/litre or 0.20%, and TZS 4.32/litre or 0.28%, respectively.
- (c) The Authority would like to remind the public that, these cap prices can be accessed through mobile phones by dialling ***152*00#** and then following the provided instructions. This service is free of charge and is available in all mobile phone service providers in the country.
- (d) In line with the prevailing sector legislation (**Petroleum Act, 2015, section 166**), prices of petroleum products are governed by rules of demand and supply. EWURA shall continue to encourage competition in the sector by making available petroleum products pricing information including price cap. This information on prices is intended to enable stakeholders make informed decisions on petroleum prices at any particular time.
- (e) Oil Marketing Companies are free to sell their products at a price that gives them a competitive advantage provided that, such **price does not exceed the price cap for the relevant product as was computed using the approved formula, which was gazetted through the Government Notice No. 70 published on 12 February 2016.**

- (f) All petrol stations should publish petroleum product prices on clearly visible boards. The price boards should be clearly visible and should clearly show prices charged, discounts offered as well as any trade incentives or promotions on offer. Consumers are advised to purchase from stations that sell products at the most competitive prices. **It is an offence not to have prices published on boards located in clearly visible places in front of petrol stations and it will attract punitive measures from EWURA.**
- (g) Retailers must issue receipts with respect to all sales that they make and consumers are required to **demand and keep receipts** that clearly show the name of petrol station, date on which such purchase was made as well as, the type of fuel and price per litre for every purchase they make. This can be used as an exhibit in case of a complaint lodged in the event that the selling price is above the cap price or in case the products sold do not meet the approved specifications.
