**PUBLIC NOTICE ON CAP PRICES FOR PETROLEUM PRODUCTS EFFECTIVE
WEDNESDAY, THE 7th DECEMBER, 2016**

The Energy and Water Utilities Regulatory Authority (EWURA) hereby publishes cap petroleum products prices, applicable in Tanzania Mainland. These retail and wholesale prices are applicable effective **Wednesday, the 7th December, 2016**. Furthermore, kindly, take note of the following:

- (a) Retail and wholesale prices for all petroleum products have changed, compared to prices that were published on 2nd November, 2016. For December 2016, retail prices of Petrol, Diesel and Kerosene have increased by TZS 29/litre or 1.59%, TZS 78/Litre or 4.53% and TZS 68/litre or 4.08% respectively. Similarly, compared to the last month publications, wholesale prices for Petrol, Diesel and Kerosene have also increased as follows: TZS 29 /litre or 1.68%, TZS 78/Litre or 4.84% and TZS 68/litre or 4.36%, respectively. To a large extent, the continued increases in the local market prices, have been caused by the increase of prices of petroleum products in the world market.
- (b) Retail and wholesale prices of Petrol, Diesel for Tanga Region have also increased compared to prices that were published on 2nd November, 2016, while for Kerosene price decreased. Retail prices for Petrol and Diesel have increased by TZS 8/litre or 0.43% and Diesel by TZS 14/litre or 0.80%, while kerosene price has dropped by TZS 3/litre or 0.16%. Likewise, wholesale prices for Petrol and Diesel have increased by TZS 8/litre or 0.45% and Diesel by TZS 14/litre or 0.86%, while Kerosene price has dropped by TZS 3/litre or 0.17%. The decrease in kerosene price has been caused by the significant decrease of premium and slight increase of its world oil market price when compared to Diesel and Petrol.
- (c) The Authority would like to remind the public that, these cap prices can be accessed through mobile phones by dialling ***152*00#** and then following the provided instructions. This service is free of charge and is available in all mobile phone service providers in the country.
- (d) In line with the prevailing sector legislation (**Petroleum Act, 2015, section 166**), prices of petroleum products are governed by rules of demand and supply. EWURA shall continue to encourage competition in the sector by making available petroleum products pricing information including price cap. This information on prices is intended to enable stakeholders make informed decisions on petroleum prices at any particular time.
- (e) Oil Marketing Companies are free to sell their products at a price that gives them a competitive advantage provided that, such **price does not exceed the price cap for the relevant product**

as was computed using the approved formula, which was gazetted through the Government Notice No. 70 published on 12 February 2016.

- (f) All petrol stations should publish petroleum product prices on clearly visible boards. The price boards should be clearly visible and should clearly show prices charged, discounts offered as well as any trade incentives or promotions on offer. Consumers are advised to purchase from stations that sell products at the most competitive prices. **It is an offence not to have prices published on boards located in clearly visible places in front of petrol stations and it will attract punitive measures from EWURA.**
- (g) Retailers must issue receipts with respect to all sales that they make and consumers are required to **demand and keep receipts** that clearly show the name of petrol station, date on which such purchase was made as well as, the type of fuel and price per litre for every purchase they make. This can be used as an exhibit in case of a complaint lodged in the event that the selling price is above the cap price or in case the products sold do not meet the approved specifications.
