**PUBLIC NOTICE ON CAP PRICES FOR PETROLEUM PRODUCTS EFFECTIVE
WEDNESDAY, 7th October 2015**

The Energy and Water Utilities Regulatory Authority (EWURA) hereby publishes cap petroleum products prices, applicable in Tanzania Mainland in the month of October 2015. These retail and wholesale prices are applicable effective **Wednesday 7th October 2015**. Furthermore, please take note of the following:

- (a) Retail and wholesale prices for all petroleum products have changed, compared with prices that were applicable effective 2nd September 2015. Retail cap prices for the month of October 2015, for Petrol, Diesel and Kerosene, compared to the month of September, have decreased by TZS 67/litre or 3.12%, TZS 4/litre or 0.20% and TZS 37/litre or 2.10%, respectively. Similarly compared to the last month publications, wholesale prices for Petrol, Diesel and Kerosene have decreased by TZS 67.28 /litre or 3.28%, TZS 3.69/litre or 0.21% and TZS 37.15 /litre or 2.23% respectively. These movements are to a larger extent attributed to changes in prices of petroleum products in the world market.
- (b) The public is informed that effective July 2015 BPS imports are also offloaded through Tanga port. In this regard, computations of petroleum products for wholesalers and retailers selling products received through Tanga will be made based on actual costs applicable for the Tanga port and distances to respective regions/districts.
- (c) In line with the prevailing sector legislation, prices of petroleum products are governed by rules of supply and demand. EWURA shall continue to encourage competition in the sector by making available petroleum products pricing information including price cap. This information on prices is intended to enable stakeholders to make informed decisions on petroleum prices at any particular time.
- (d) Oil Marketing Companies are free to sell their products at a price that give them a competitive advantage, provided that such **price does not exceed the price cap for the relevant product as was computed by the approved formula which was gazetted through the Government Notice No. 405/2015 of July 2015.**
- (e) All petrol stations should publish petroleum product prices on clearly visible boards. The price boards should be clearly visible and should clearly show prices charged, discounts offered as well as any trade incentives or promotions on offer. Consumers are advised to purchase from those stations that sell products at the most competitive prices. **It is an offence not to have prices published on boards located in clearly visible places in front of petrol stations and it will attract punitive measures from EWURA.**

- (f) Retailers must issue receipts with respect to all sales that they make and consumers are advised to **demand and keep receipts** that clearly show the name of petrol station, date on which such purchase was made as well as, the type of fuel and price per litre for every purchase they make. This can be used as an exhibit in case of a complaint lodged in the event that the selling price is above the cap price or in case the products sold are off the approved specifications
