## **LOCAL SUPPLIERS AND SERVICE PROVIDERS DATABASE**

1. Pursuant to Regulation 38(1) of the Petroleum (Local Content) Regulations, 2017, the Energy and Water Utilities Regulatory Authority “the Authority” informs the petroleum industry operators, suppliers, service providers and the general public that the Local Suppliers and Service Providers Database for the year 2018 “LSSP 2018” was initially published on 11<sup>th</sup> June, 2018. Since the registration is an on-going exercise, the Authority updates the LSSP each month as fresh applications are received and processed.

2. The Authority wishes to inform the petroleum industry operators, suppliers, service providers and the general public that it has updated the LSSP for the month of June 2019 with 392 local business entities. The approved suppliers and service providers are eligible to participate in the execution of works and provision of various goods and services in the petroleum midstream and downstream activities in Mainland Tanzania.
