Additional Conditions
1. This Order shall be cited as the Korogwe Water Supply and Sanitation Authority (Korogwe WSSA) (Provisional Tariffs) (Amendment) Order, 2019, and shall be read as one with the Korogwe Water Supply and Sanitation Authority (Korogwe WSSA) (Provisional Tariffs), Order, 2016.
  2. This amendment Order shall come into force on 1<sup>st</sup> December 2019 and remain in force until new tariff is approved by EWURA.
  - 3.-(1) The principal Order shall remain in operation except for the tariffs and charges stipulated under Schedule 1.3 and 1.4 of the First Schedule.  
(2) The First Schedule is amended in the manner prescribed in the Schedule to this Order.
  4. The principal Order is amended by adding to the conditions stipulated in the principal Order the following:
    - (a) on 31<sup>st</sup> December 2019 or before, submit approved business plan by Korogwe WSSA Board;
    - (b) implement conditions which are not fully implemented in the principal Order; and
    - (c) increase hours of service to 12 hours.
