On 20<sup>th</sup> February 2020, EWURA received Tariff Application from Nzega Water Supply and Sanitation Authority (Nzega WSSA) requesting for a multi - year tariff adjustment (2020/21 – 2022/23) for water supply services. Tables 1 to 3 below show current and proposed tariffs and fees.

According to Nzega WSSA, after the review of its tariff the utility will be able to meet operation and maintenance costs in the implementation of new Lake Victoria Project that is expected to commence in March 2020.

The main objective of the meeting is to collect views of stakeholders including Government Consultative Council (GCC), Consumer Consultative Council (CCC), Nzega WSSA's customers and the general public on the reasonableness of the proposed tariff application.
