AT DOMINIKI VILLAGE, MKALAMA DISTRICT IN SINGIDA REGION**

PRELIMINARIES

EWURA has noted with concern that Dominiki Filling Station has constructed a retail outlet located at Dominiki Village, Mkalama District in Singida Region, without having applied and obtained a construction approval from EWURA contrary to section 127 (1) of the Petroleum Act, Cap.392 which requires any person intending to construct a petroleum installation facility to apply and obtain a construction approval from EWURA before construction of the said facility.

Constructing a petroleum installation facility without obtaining a construction approval from EWURA contravenes the law and is punishable as such.

ORDER

THEREFORE, and based on the foregoing EWURA has considered the matter in accordance with the applicable laws and has decided that **Dominiki Filling Station** located at **Dominiki Village, Mkalama District in Singida Region** be and is **HEREBY ORDERED** to;

- (a) immediately stop undertaking ongoing construction at your facility located at **Dominiki Village, Mkalama District in Singida Region**; and

- (b) explain in writing within seven (7) days from the date of receipt of this Order why severe punishment should not be taken against **Dominiki Filling Station** for undertaking construction of a retail outlet at **Dominiki Village, Mkalama District** in **Singida Region** without obtaining a construction approval from EWURA contrary to section 127(1) of the Petroleum Act, Cap 392.
