PUBLIC NOTICE

(Issued pursuant to Section 19(2) (a) of EWURA Act, Cap. 414)

NOTICE is hereby issued to the public that the Energy and Water Utilities Regulatory Authority (EWURA), has received an application for a Water Supply and Sanitation Licence from Same - Mwanga Water Supply and Sanitation Authority (Same - Mwanga WSSA) ("the Applicant") for provision of water supply and sanitation services in Same Town, Mwanga Town, part of Same, Mwanga and Korogwe Districts covered by Same - Mwanga - Korogwe Water Supply Project. EWURA is inviting comments from the public on the application. Particulars of the Applicant are as provided below:

1: Name and address

2: Type of License Applied
Licence to provide Water Supply and Sanitation Services in Same Town, Mwanga Town, part of Same, Mwanga and Korogwe Districts covered by Same - Mwanga - Korogwe Water Supply Project.
3: Water Sources and Infrastructures
Same - Mwanga Water Supply and Sanitation Authority (Same - Mwanga WSSA) has two major water sources, namely ground and surface water sources. The ground water source has a total of seven (7) boreholes with a total water production capacity of 5,450 cubic meters per day and the surface water source has a total of two (2) springs with a total water production capacity of 111 cubic meters per day. The applicant's water production and storage infrastructure consist of fourteen (14) water tanks with a total storage capacity of 1,609 cubic meters. Also, the applicant has water network with a total length of 139.92 km and sixty five (65) water kiosks.
4: Ownership Structure
Same - Mwanga Water Supply and Sanitation Authority is 100% owned by the Government of the United Republic of Tanzania.
