EWURA Board of Directors Visit Electricity Infrastructure

WURA's Board of Directors accompanied by Members of Management has recently made a visit to TANESCO infrastructure at Zuzu Grid Power Substation in Dodoma Region, as a part of the routine process in order to be more informed on the implementation of the electricity infrastructure projects.

The Board paid visit to the existing ZUZU Power Grid Substation 200MW, the Old Zuzu Diesel Power substation 7.4MW and the 400kV Backbone Transmission Investment Project Phase II.

The Board observed that the project implementation status so far was encouraging, however, insisted the need to improve and fast track its completion in order to improve power services delivery in the country.

Speaking during the visit, the Deputy Board Chairman, Mr. Ahmad Kilima appreciated the

progress so far reached in the implementation of the project.

"We appreciate the Government efforts to implement major electricity infrastructure projects of 400kV Backbone Transmission Power Project and the Julius Nyerere Hydro Power Project in order to stabilize power and improve power quality and reliability in Dodoma city and the entire country," said Mr. Kilima

EWURA is mandated to undertake technical and economic regulatory functions in the Electricity Sub-sector. The regulatory functions that are implemented by the Authority in the Electricity Sub-sector are geared towards, efficient and safe operation of the Electricity Supply Industry, protection of interests of consumers, the Government and other Stakeholders; and attraction of investments into the Sub-sector.



Stakeholders sign MoU on infrastructure way leaves

he safety risks associated with uncontrolled third-party activities in the shared way leaves that host multibillion dollars' worth of energy, water, transport and communications infrastructure will now be history, after signing of a Memorundum of Understanding (MoU) by stakeholders of the infrastructure recently.

The move, spearheaded by the Energy and Water Utilities Regulatory Authority (EWURA), will see establishment of rules to govern underground infrastructure management system during maintenance, repairs and construction involving excavations along the way leaves.

The Acting Director General of EWURA, Eng. Godfrey Chibulunje said the Memorandum of Understanding (MoU) will enable parties develop a guiding framework for shared way-leaves to make a strong regulatory framework to protect the underground infrastructure.

"Now that the MoU is signed, a Joint Technical Committee and binding guidelines consistent with the MoU would be formed, and EWURA will monitor members' compliance to Rules, Regulations, Guidelines and agreed best practices, which will also help the Authority when it comes to dispute resolutions," he said.

The MoU will be used as a tool to enhance public safety and increase the integrity and reliability of Tanzania's underground utility infrastructure, through development and implementation of effective and efficient damage prevention practices across the country.

Signatories of the MoU are the Tanzania Telecommunications Company Limited (TTCL), Dar es Salaam Water and Sewerage Authority (DAWASA), Pan African Energy (PAET), SONGAS, and Tanzania Petroleum Development Corporation (TPDC).

Others are Tanzania Electric Company Limited (TANESCO), Maurel & Prom, TANROADS, TARURA, Tanzania Zambia Railway Authority (TAZARA) and TAZAMA Pipelines Limited.

In the recent years, there have been an increase in number of incidents resulting from uncontrolled third-party activities in the shared way leaves.

"As a result of these incidents, EWURA, TPDC and PAET in 2018 discussed and agreed for an urgent need to engage a wider spectrum of stakeholders—for both the owners and users of the way leave, to work on possible coordinated underground infrastructure management system during maintenance, repairs and construction involving excavations," said the Ag. Director General.

According to EWURA chief, there has been numerous incidents that threaten the shared way leaves. Such incidents include an accident in April 2014 at Kurasini Darajani, where China Railway Construction Engineering Group (CRCEG) was reported to have damaged an underground gas pipeline by excavator.

InMay 2014, Shalom Engineering (Nat Oil Contractor) damaged the same gas pipeline at Kurasini near Tanzania Episcopal Council, in January 2018, an excavator engaged by DAWASCO punctured a gas pipeline at Buguruni kwa Mnyamani damaging properties and infrastructure, and in September, 2018 the Standard Gauge Railway contractor (Yapi Merkezi) punctured a gas pipeline at Ilala Bungoni in Dar es Salaam.

In a quest for a solid solution to the problem, EWURA in collaboration with America's National Association of Regulatory Utility Commissioners (NARUC) and United States Agency for International Development (USAID), two years ago organized a ttechnical workshop on Gas Pipeline Safety to discuss the impact and mitigation measures of risks posed by third party activities within the natural gas network way leaves.

The technical workshop had passed a resolution that EWURA should spearhead formation of MoU to provide for a framework towards mitigation measures. Each organization signing the MoU will have two personnel to form a Joint Technical Committee as per Article 3 of the MoU.

The Joint Technical Committee, will then embark on the preparation of the guidelines.

he government has re-configured service areas covered by some Water Supply and Sanitation Authorities, in a move that targets to improve efficiency and enhance service delivery.

The changes have seen some Water Supply and sanitation authorities dissolved while others merged.

According to a statement from the Ministry of Water, 12 Water Supply and Sanitation Authorities in urban centres have been given more areas to provide services.

The Mangaka area, which is an urban centre for Nanyumbu district, for instance, will be operating under the Masasi-Nachingwea Water Supply and Sanitation Authority (MANAWASA). Subsequently, The Mangaka Urban Water and sanitation Authority (Mangaka UWSSA) has been dissolved.

In the new configuration, the Maswa Urban Water Sanitation and Sanitation Authority (MAUWASA) has been allocated with more service areas of Lalago, Malampaka and Sangamwalugesha. Following implementation of this decision, water authorities in these areas have been dissolved.

Other six Water Supply and Sanitation Authorities in regional centres and townships

have been assigned to administer and undertake capacity building initiatives for Water Supply and Sanitation Authorities in peri-urban centres and district townships in their respective regions.

Supervision of these water authorities would follow guidelines for managing Water Authorities issued by the Ministry in December 2019.

As a result of these structural decisions, board of directors in such water Authorities have been dissolved and their roles and responsibilities would be performed by respective boards in mentioned authorities.

The new changes will also mean that water service in other 63 townships will be under the supervision of the Rural Water Supply and Sanitation Agency (RUWASA). Following the decision, respective board of directors have been dissolved and their duties would be performed by RUWASA Board of Directors.

The reconfiguration decision has also resulted into formation of three new Water and Sanitation Authorities by merging service areas.

These are Kyela -Kasumulu Water Supply and Sanitation Authority (Mbeya); Itigi - Manyoni Water Supply and Sanitation Authority (Singida); and Same - Mwanga Water Supply and Sanitation Authority (Kilimanjaro).

he Energy and Water Utilities Regulatory Authority (EWURA), has conducted awareness training on regulation of energy and water services for people with albinism in Dodoma region.

Speaking recently during the opening of the training, EWURA Central Zone Manager, Engineer Norbert Kahyoza said the training will help the group to become ambassadors of EWURA, in educating their peers, on their responsibilities as consumers, as well as those of service providers on energy and water sectors.

"I call upon you to help us spread this knowledge to others, who have not been fortunate enough to attend this training," said Engineer Kahyoza.

He noted that the training is designed to help them to know about EWURA, its activities such as licensing to electrical contractors and wiremen and petrol stations and their conditions, as well as rules and regulations which bound them and complaints handling procedures. On the other side, the Executive Director of the Albinism Awareness Foundation (AAF), Selemani Magoma, thanked EWURA for the training, saying it will facilitate the group's participation in various development activities in the country, including the energy and water sector regulated by EWURA.

"EWURA has recognized people with albinism as key stakeholders in development issues and find the need to involve us, in educating on various functions and responsibilities of EWURA," he added.

The Chairman of the People with Albinism in Dodoma Region, Ludovick Julius appreciated EWURA for the programme, saying it will assist them in case of any problem concerning energy and water service providers.

EWURA will continue to enhance the welfare of Tanzanian society, by enhancing public knowledge, awareness and understanding of regulated sectors, including the rights and responsibilities of consumers and regulated suppliers, complaints handling procedures, duties functions and activities of the Authority.



Board applauds reverse osmosis plant

he Board of Directors for the Energy and Water Utilities Regulatory Authority (EWURA), has commended the performance of a saltwater filtering project(Reverse Osmosis), located at Gairo District in Morogoro region.

The Deputy Chairman of the Board, Mr. Ahmad Kilima said during a recent visit that, his Board has been satisfied with the saltwater filtering plant and that the project has eliminated the longtime water scarcity to Gairo residents.

"EWURA is satisfied and we applaud the performance of this project, as it helps significantly resolving the longtime challenge of water shortages," said Mr. Kilima.

Mr. Kilima pledged continuous monitoring of other challenges, including that of electricity in the plant.

The Reverse Osmosis plant was imported from Italy at a cost of Tsh. 2.3 billion. It is expected that 32,808 citizens in the district would be served by the plant, by raising water supply rate from the previous 38 percent to 80 percent.

The Gairo District Commissioner, Ms. Siriel Mchembe, called on the citizens to ensure they take care of the project's infrastructure, and the Government will not hesitate to take legal actions against anyone who will sabotage or destroy the project.

On his side, the Rural Water Supply and Sanitation Agency (RUWASA) Manager for Gairo District, Engineer Moses Msuya, said the construction of the reverse osmosis plant for filtering saltwater, has helped to improve access to clean and safe water to Gairo residents.

Furthermore, Gairo citizens expressed their sincerely appreciation to the Government for helping them to solve that longtime challenge, and they promised to support the Government's efforts on various existing projects.

EWURA is responsible for technical and economic regulation of water supply and sanitation services in Tanzania. Regulation is important since water entities are operating in a monopolistic business environment, with limited competition, that would otherwise derail the quality of service provided to consumers adequately.
