**PUBLIC NOTICE**

**(Issued pursuant to Section 19(2) (a) of EWURA Act, Cap. 414)**

**NOTICE** is hereby issued to the public that the Energy and Water Utilities Regulatory Authority (EWURA), has received an application for a Water Supply and Sanitation License from Babati Water Supply and Sanitation Authority (WSSA) (“the Applicant”) for provision of water supply and sanitation services in Babati town, Bashnet, Dareda, Gallapo, Magugu and Katesh townships, in Manyara Region. EWURA is inviting comments from the public on the application. Particulars of the Applicant are as provided below:

<b>2: Type of License Applied</b>
Licence to provide Water Supply and Sanitation Services in Babati, Bashnet, Dareda, Gallapo, Magugu and Katesh Townships.
<b>3: Water Sources and Infrastructures</b>
Babati Water Supply and Sanitation Authority (Babati WSSA) has two major water sources; ground and surface water. The ground water source consist of twenty three (23) boreholes while the surface water source consist of twelve (12) river and spring intakes. The combined installed water production capacity for all water sources is 29,240 cubic meters per day. The applicant’s water production and storage infrastructure consist of sixty one (61) water tanks with a total storage capacity of 5,454 cubic meters. Also, the applicant has water network with a total length of 758.11km and 283 water kiosks.
<b>4: Ownership Structure</b>

Babati Water Supply and Sanitation Authority (Babati WSSA) is 100% owned by the Government of the United Republic of Tanzania.
