- Amendment of Schedule

These Rules may be cited as the Energy and Water Utilities Regulatory Authority (Petroleum Products Prices Setting) (Amendment) Rules, 2020 and shall be read as one with the Energy and Water Utilities Regulatory Authority (Petroleum Products Prices Setting) Rules, 2009 herein after referred to as the ‘principal Rules’.
