PUBLIC NOTICE

NOTICE is hereby issued to the public that the Energy and Water Utilities Regulatory Authority (EWURA), has received an application for a Water Supply and Sanitation Licence from Geita Water Supply and Sanitation Authority (Geita WSSA) ("the Applicant") for provision of water supply and sanitation services. EWURA is inviting comments from the public on the application. Particulars of the Applicant are as provided below:

2: Type of Licence Applied
Licence to provide Water Supply and Sanitation Services in Geita Town; and Mbogwe Ward, Nyasato Ward, Masumbwe Ward, Nyakafuru Ward, Nhomolwa Ward and Iponya Ward in Mbogwe District.
3: Water Sources and Infrastructures
Geita Water Supply and Sanitation Authority (Geita WSSA) has thirteen (13) water sources which are Kambarage Borehole, Kagera A Borehole, GESECO Borehole, Nyankanga dam, Geita Bus Stand Borehole, Kasamwa Borehole, Kibilani Borehole, Wahanga Borehole, Mgusu Borehole, Nyakafuru Borehole, Shenda Borehole, Belwa Borehole and Igembesabho Borehole. The water production capacity is 7,999 cubic meters per day. The applicant's water production and storage infrastructure consist of nineteen (19) water storage tanks with a total storage capacity of 3,345 cubic meters. Also, the applicant has water network with a total length of 118.9km and one hundred and thirteen (113) water kiosks.
4: Ownership Structure
Geita Water Supply and Sanitation Authority (Geita WSSA) is 100% owned by the Government of the United Republic of Tanzania.
