PUBLIC NOTICE

(Issued pursuant to Section 19(2) (a) of EWURA Act, Cap. 414)

NOTICE is hereby issued to the public that the Energy and Water Utilities Regulatory Authority (EWURA), has received an application for a Water Supply and Sanitation Licence from Nzega Water Supply and Sanitation Authority (Nzega WSSA) (“the Applicant”) for provision of water supply and sanitation services in Nzega Town, Tabora Region. EWURA is inviting comments from the public on the application. Particulars of the Applicant are as provided below:

2: Type of Licence Applied
Licence to provide Water Supply and Sanitation Services in Nzega Town.
3: Water Sources and Infrastructures
Nzega Water Supply and Sanitation Authority (Nzega WSSA) draws water from three (3) water sources which are Uchama dam, boreholes and Bulk Water Supply from Kahama Shinyanga Water Supply and Sanitation Authority (KASHWASA). The combined production capacity of all water sources is 12,880 cubic meters per day, which is sufficient to meet the water demand of 5,664 cubic meters per day. The applicant's water production and storage infrastructure has a total storage capacity of 4,450 cubic meters. Also, the applicant has water network with a total length of 465 km with a total of one hundred and fourteen (114) water kiosks.
4: Ownership Structure
Nzega Water Supply and Sanitation Authority (Nzega WSSA) is 100% owned by the Government of the United Republic of Tanzania.
