THE ELECTRICITY (WATU NA UMEME TANZANIA LIMITED ("WATU NA UMEME")
TARIFF ADJUSTMENT FOR ELECTRICITY SERVICE) ORDER, 2022

- Citation
1. This Order may be cited Electricity (Watu na Umeme Tanzania Limited) (Watu na Umeme) (Tariff Adjustment for Electricity Service) Order, 2022.
- Approval of tariffs and charges
2. Watu na Umeme Limited tariffs and charges as specified in the Schedule to this Order are hereby approved.
- Conditions
3. This Order is issued under the following conditions:
- (a) on or before 31st March 2023, Watu na Umeme Tanzania Limited shall submit a Business Plan that incorporates the approved tariffs and the plan shall include expansion plan to serve the current demand and prospective customers;
 - (b) on or before 30th June 2023, Watu na Umeme Tanzania Limited shall prepare and submit to the Authority for approval its Customer Service Charter;
 - (c) on or before 31st March 2023, Watu na Umeme Tanzania Limited shall modify its billing system to ensure purchase of electricity is done in unit per shillings and customer should be able to view consumption;

- (d) on or before 31st March 2023, Watu na Umeme Tanzania Limited, shall ensure all defective customer meters have been replaced and ensure availability of the same for future use; and
- (e) on quarterly basis, Watu na Umeme shall provide Energy and Water Utilities Regulatory Authority with information about its financial and operating condition in accordance with the requirements of Energy and Water Utilities Regulatory Authority.
